## Invest for Wellness

Swasti's flagship programme, Invest for Wellness (i4We), provides affordable and accessible primary care through nurse practitioners and protocol based treatment, and proactively prevents diseases/conditions among poor communities. Individuals in the community willing to save for their health needs become members of i4We.

i4We improves the health of the rural and urban poor by combining core medicine, behaviour change and health financing. The programme has been implemented in Mohammadpur, Gurgaon in the past year and was recently launched in Bommanahalli, Bengaluru and for rural poor communities in Hoshangabad district, Madhya Pradesh in 2017.

## Our Programmes

Our ongoing and new programmes helped people, governments and development partners to shape safer and secure, healthier and prosperous lives across the world.

Members get health advice, are assured treatment and have priority access to services to screen, prevent, and treat 10 common and high burden conditions and diseases. i4We educates and counsels, forms support groups, encourages use of health products and mobilises community action on sanitation, air, water and food determinants to influence change.

## Sexual And Reproductive Health And Rights

Our efforts in Sexual and Reproductive Health and Rights (SRHR) championed women's rights to lead violence free lives, created a vibrant community platform-Taaras, for long term community action and stakeholder engagement, and strengthened community institutions for sustainable behaviour change. We worked with women in sex work and their children, marginalised gay men and transgender people; and people living with HIV across five states in India.

GenY, a new initiative under SRHR, create safe spaces to empower gender nonconforming and gender questioning youth to be resilient and self reliant. It seeks to provide support irrespective of social status, gender identity or sexual orientation by establishing local chapters comprised of counselling services, gender orientation and life skills training workshops.

Using a life skills approach, we improved SRHR related knowledge and behaviour among women and men in 100 factories.

*"I entered sex work to sustain myself. There, I met a man who I fell in love with and who lives with me. In the beginning he was alright but soon his gambling addiction started to emerge. He began to physically torture me if I did not give him the money that I earned. After tolerating his violence for the longest time, I approached the police to file a case against him. But the police were unwilling to help me. That is when the organisation came to my aid. They intervened by counselling us and helping us work through our problems. Our relationship is much better now."*

## Water, Sanitation And Hygiene

Our Water, Sanitation and Hygiene (WaSH) initiatives reduced disease incidences by educating and engaging local governments, village communities and schools, and improving drinking water systems, access to toilets and handwashing facilities. Eleven community water plants, across 50 villages and water distribution points were established in remote villages.



Swasti's WaSH initiatives across two urban slums (Mohammadpur and Bommanahalli) and one district of Chikballapur have encouraged healthy behaviours, strengthened water supply chains, and ensured equitable access to services for who have less ability to pay. Water plants and behaviour change communication in community and schools for children, mothers and caregivers have brought about positive WaSH behaviours including cleaner neighbourhoods.

*"Students and teachers did not give much importance to sanitation and hygiene, but working with Swasti has created awareness and importance of good hygiene and sanitation habits among students and teachers by WaSH training and building toilet in the school. Children now take extra efforts towards personal hygiene, keeping the toilet and surroundings clean".*

## Life Skills For All

Swasti's work in the area of Life Skills for All (LSA), in 2016-17, saw us deepening our efforts to contribute to worker well being. We evolved a comprehensive worker well-being framework, which seeks to address the gamut of workers' issues such as health, gender, financial inclusion and life skills with empowerment as the core approach. The framework while positively impacting workers' personal lives also adds value to business growth for companies.

Research focused on worker wellbeing framework helped us understand the factors that hinder quality of life of the workforce, as well as sectoral interest and commitment in achieving worker wellbeing.

In the past year, we impacted the lives of thousands of workers across factories that are part of the global supply chain in three South Asian countries, and seven States and one Union Territory in India.

*"I did not have friends because I am differently abled. None of the marriage proposals worked out. I was unhappy. The Women in Factories programme changed my perspective towards self. I realised that 'disability' is only in my mind. The training made me confident and courageous. I realised that women are not meant only to get married and have children. There are many things beyond these in the world to be achieved. I want to be like that - an achiever."*

## Accelerating Impact Through Technology

Technology is integral to our strategies to drive change. We enable our people to adopt technology to collaborate, learn, and shape new solutions. From enabling work collaboration to service delivery and insights driven decision making, technology use makes us an agile and efficient organisation.

### ● mCollect: Streamlining crowd-funding

mCollect is a mobile and web based technology solution to streamline local, member-based crowdfunding process. It was customised, piloted and scaled up as part of the Swa Shakt campaign, where members of community organisations (CO) raised money from their networks for the CO. The technology solution tracks donations, gives real time information on contributions to both donors and COs, and generates reports. mCollect has tracked donations worth INR 56,00,000 raised by 6000+ members from 35 COs as of 31 March 2017. Swasti partnered with Afixi technologies to customise mCollect.

### ● Taaras: Deepening community engagement

Taaras is an android application with an integrated web platform used by 400+ staff in one of the biggest health programmes, Avahan III, in India. The App provides live, quality field information, aids better supervision and support through back end analytics and helps nuanced service delivery. A light and visual rich App, it works on any android phone, off and online mode, and has multilevel security of data. Taaras has helped track the vulnerability status and service delivery and uptake by 1,21,000+ members, increasing community engagement from 56% to 73%, over five years. Swasti partnered with Converbiz to develop Taaras.



### ● Milestone: Enabling better decision making

The Milestone App is an android application, which tracks the milestones of a programme or an organisation. In large organisations, work across levels, areas and departments can be better followed using Milestone. The App helps to use data for effective decision making and better manage projects. Swasti developed Milestone with CEA Technologies for the United Nations Office on Drugs and Crime, Nigeria and the Government of Nigeria.

### ● PHC App: Delivering better primary healthcare

Swasti's flagship programme i4We will use a mobile and web-based application, PHC App, for delivering primary healthcare. The application will provide an integrated decision support system with a user friendly interface for primary and promotive healthcare. Driven by artificial intelligence, it will predict the risk factors and probability of an individual/family falling sick. This will help the programme be more proactive in its approach to prevent illnesses.

### ● WaSH App: Monitoring WaSH in healthcare facilities

The WaSH App gives real time dashboards on WaSH conditions at healthcare facility level and comparative data from facilities at block, district, state and national levels. This will allow for continuous monitoring that can improve treatment outcomes and reduce maternal and neonatal morbidity and mortality. Swasti partnered with Converbiz to develop the application.

### ● Interactive Voice Response System: Collecting systematic feedback

The Interactive Voice Response System (IVRS) allows community members to feedback on a range of HIV prevention and treatment services received. Anyone wishing to provide feedback gives a missed call to a mobile number. They then receive a call and are taken through a series of questions for which they provide responses using the number-pad of their phone (i.e. 1 for yes, 2 for no etc). Voice recording for certain questions also enable qualitative data to be captured. Swasti piloted IVRS in Maharashtra and believes that investment in technology and building support for its use within the community can make IVRS based feedback effective. Swasti worked with OnionDev (aka GraamVani) to set up the system.

# Our Partnerships

We strengthened partnerships with respected donors, iconic brands and reputed research institutions to break into new areas of work, and scale and deepen our ongoing efforts.



Our long term partners Bill & Melinda Gates Foundation (BMGF), GAP Inc., Business for Social Responsibility (BSR), and 85 Community Organisations continued to trust us to deliver impact. New partnerships with Women Win, Naaz Foundation, Drinkwell, AIDS FONDS, National AIDS Research Institute (NARI), Catalyst

Management Services and Vrutti Livelihood Resource Centre supported our work in new geographies and thematic areas.

## Strategic Alliances Strengthened Our Efforts to Influence Global Health Programmes And Agendas

We contributed to the Mid-Term Assessment of the **National AIDS Control Programme IV, UN Women's global consultation** on sex work, the 2030 agenda and gender inequality, and implementation of International and Regional Standards on Violence Against Women for the UN Special Rapporteur on Violence Against Women.

We participated in the round table discussion on **Eliminating violence against women** at work both in formal and informal sectors organised by the German brand C&A.

**WHO SEARO** partnered with us to design strategies to end communicable diseases in the South East Asian region, and eliminate Leishmaniasis (Kala-azar) with a focus on India.

# People Engagement

Swasti's journey of more than a decade has witnessed giant strides in addressing public health issues. It was made possible by its most valuable asset – People. Swasti attracts and retains top talent from the world over.

In 2016-'17, the Swasti family was 132 members strong including interns, staff and consultants. Students from prestigious universities across the world, such as Institute of Rural Management, Anand (IRMA), Indian Institute of Management Bangalore, Oregon State University, Yale University, Boston University, worked with us. Our continued partnerships with organisations such as IDEX Global Fellowship and Cross Fields have helped us in hosting bright and experienced interns.
